DISCUSSION QUESTIONS

- Why is it important to realize that, when considering the historical evidence for Christ's Resurrection, we do not investigate it any differently than other historical events?
- Which supporting evidence for the fact that Jesus' tomb was found empty most impresses you: that the empty tomb account is found in multiple, independent sources, that women are portrayed as the first to discover the empty tomb, or the earliest Jewish polemic of Matthew 28:11-15?
- Which supporting evidence for the fact of Jesus' post-mortem appearances most impresses you: that their accounts are, again, found in multiple, independent sources, or that at least two people Jesus appeared to were unbelievers at the time?
- 4 How compelling is it that the disciples came to believe in the Resurrection?
- What difference does it make to your faith that Christ's Resurrection is an actual, historical event and not merely a mythical, legendary story?
- The majority of scholars agree that our three main facts are true, but many don't accept the Resurrection as the explanation of those facts. What are some possible alternative explanations, and how well do they explain the evidence?
